**MINUTES OF MEETING-MARCH 7, 2011**

Fiscal Officer read the minutes of the previous meeting, which were approved by the Board with a change.

**Old Business**

Saling- None

Lang- Miami Valley, who originally ordered the 09 Truck will send invoice to Lucas who will forward to us. Ace estimates \$1000 to shorten frame and move gas tank. Trustees agreed with estimate and will proceed.

Trustees agreed to put 1" of asphalt on Pleasant Chapel Rd. between Fairview and Flintridge as it no longer can be patched successfully.

Clark- Reported that Mr. Church on Panhandle has let his cows roam and they are causing property damage at Brent Dewey's. Clark advised Dewey to call the sheriff and let them handle the problem.

**Safety Issues-** There is a wash out @ Kim Metheny's driveway that Rick will fix.

**Zoning-** Inspector Long reported Tim Warner's zoning permit check was returned and that he was supposed to bring cash to tonight's mtg. Clark got a message from him that there was an emergency and he will contact F.O. Also reported that she took a call from Dennis McDonald who will be putting a house on Dodd's Rd. across from Shook's. No permit yet, as he doesn't have a contract on which house yet.

**Fiscal Officer-Long –** Presented trustees with a draft copy of the AUP audit with no findings.

Payments in the amount of \$9,549.68 were made and there are funds on hand or in the process of collection to pay the bills as presented, Molly Long, Fiscal Officer.
